

NEW LAWS TAKING EFFECT – APRIL 2024

Effective Date	Chapter	Summary
4/1/2024	Ch. 59 of 2022 Part J, Sec. 3 S.8009-C A.9009-C	Extends the credit against income tax for individuals or entities investing in low-income housing.
4/1/2024	Ch. 532 of 2023 S.2712-B A.4755-B	Pays drug-impaired driving surcharges to counties for programs and initiatives to reduce drug-impaired driving incidences.
4/1/2024	Ch. 609 of 2023 A.119-A S.5394-A	Provides for the issuance of a New York State Iraq War Commemorative Medal.
4/1/2024	Ch. 610 of 2023 A.121-A S.5372-A	Provides for the issuance of a New York State Afghanistan War Commemorative Medal.
4/1/2024	Ch. 616 of 2023 A.6084-A S.3309-A Ch. 103 of 2024 S.8067 A.8568	Permits Gold Star families to use any of the public campsites, parks and other public places of recreation in this state free of charge.
4/1/2024	Ch. 754 of 2023 S.1196-A A.1673-A	Requires health insurance policies and Medicaid to cover biomarker testing for diagnosis, treatment, appropriate management, or ongoing monitoring of a covered person's disease or condition when the test is supported by medical and scientific evidence.
4/6/2024	Ch. 699 of 2023 S.1690-A A.6716-A Ch. 41 of 2024 A.8537 S.8094	Assists minority and women-owned business enterprises and small businesses located in highly distressed areas with obtaining loans through the capital access program. Also requires outreach and marketing to financial institutions to increase awareness of the program.

4/10/2024	Ch. 523 of 2023 A.6134 S.6443	Provides the liquor authority the ability to set the duration of brewer licenses, farm brewery licenses and restaurant-brewer licenses to three years.
4/11/2024	Ch. 726 of 2023 S.2163-B A.5109-A	Prohibits the slaughter of a horse as well as the possession, sale, or import of a horse or horseflesh for human or animal consumption.
4/22/2024	Ch. 558 of 2023 A.5610-D S.5823-C	Prohibits the sale of over-the-counter diet pills or dietary supplements for weight loss or muscle building to people under 18 with the exception of certain protein powders, protein drinks and foods.
4/22/2024	Ch. 590 of 2023 S.5036-A A.5121-A	Requires registered wholesalers who transfill medical oxygen to ensure any person responsible for supervising such process meets certain qualifications.
4/22/2024	Ch. 593 of 2023 S.5881-A A.5549-A	Enhances rights of homeowners in manufactured home parks when owners of manufactured home parks consider selling the park.
