Assemblymember Amy Paulin, throughout her years of service, has always focused on making progress that will improve people's lives in ways large and small.

But this year was her most productive to date! She sponsored an astounding **33 bills that passed both the State Assembly and the State Senate in 2019** – the most of any member of the Assembly.

Amy Paulin's commitment to working in a bipartisan and professional way has proven to be a winning result for her constituents and the people of New York State.

Amy Paulin has authored more than 200 bills that have been signed into law since she was first elected. This year, 33 more bills passed both houses.

Preventing Gun Violence

- **Preventing Guns from Falling into the Wrong Hands** – Providing up to 30 days for the FBI to complete their background check on a gun purchase when the initial check on the buyer comes back as “delay” to keep guns out of the hands of terrorists and domestic abusers. (Ch. 129 of 2019)
- **Keeping Our Kids Safe from Gun Accidents** – Requiring the safe and secure storage of rifles, shotguns, and handguns to prevent access by children under 16 and other prohibited persons. (Ch. 135 of 2019)
- **Keeping Law Enforcement Safe through Timely Access to Firearm Records** – Providing local law enforcement with round-the-clock access to firearm records to determine whether a gun might be present in the home when they respond to calls on nights or weekends. (Ch. 244 of 2019)

Protecting Our Families

- **Enabling Victims of Domestic Violence to Vote Safely** – Allowing victims of domestic violence to vote by mail, protecting their right to vote without fear for their personal safety. (Ch. 150 of 2019)
- **Banning Dangerous Crib Bumper Pads** – Banning the sale of crib bumper pads, which have been linked to incidents of suffocation, strangulation, and other injuries to infants. (Ch. 165 of 2019)
- **Guaranteeing Informed Consent for Patients** – Making it clear that any health care procedure or exam performed for the purposes of medical education or training while a patient is unconscious still requires the consent of the patient – including pelvic and rectal exams. (A. 4988)

Improving Quality of Life

- **The Nuisance Call Act** – Requiring live telemarketers to proactively inform recipients of how they can get on the company’s “do-not-call” list and to prevent the customer’s information from being sold or distributed to a third party. (A. 2224)

Building Critical Infrastructure

- **Jump-Starting the Gateway Project** – Establishing the bi-state Gateway Development Commission to act as a coordinating agency for the nation’s most urgently-needed infrastructure project, the stretch of the Northeast Corridor railway between Newark, NJ and Penn Station, including the rehabilitation and construction of tunnels under the Hudson River. (Ch. 108 of 2019)

Promoting Ethics and Integrity

- **Keeping Dark Money Out of Our Elections** – Enshrining into state law the federal Johnson Amendment which prohibits tax-exempt religious and 501(c)(3) non-profit corporations from endorsing or opposing a candidate for political office to safeguard against federal efforts to repeal this long-standing law. (Ch. 407 of 2019)
