

As NYS Assembly Health Committee Chair, Amy Paulin's healthcare victories for the people of New York State includes legislation which:

Alleviating End-of-Life Suffering

- The Medical Aid in Dying Act provides terminally ill, mentally competent adults the option to request medication to peacefully end their suffering (A.136/S.138).
- Stops the spread of for-profit hospice care that prioritizes profits over people (A.565/S.3437).
- Improves protections for health care agents making critical end-of-life decisions (Ch. 29 of 2025).

Improving Healthcare Transparency and Education

- Helps those grieving by requiring State publication of a guide offering legal, financial, and emotional support (A.3939a/S.4351a).

Expanding Organ and Tissue Donation

- Allows close friends to authorize anatomical gifts on behalf of a deceased loved one (A.1395/S.3360).

Increasing Medical Lab Standards

- Enhances safety and oversight for clinical lab and blood bank directors (Ch. 46 of 2025).

Fighting for Dementia Sufferers

- Establishes the nation's first statewide registry for frontotemporal degeneration, aiding research and awareness by increasing data collection (Ch. 479 of 2025).

Supporting the Elderly

- Encourages the growth of senior housing by reforming regulations for retirement communities (A.1464a/S.4585).
- Promotes age-friendly hospital practices which tailor care to older adults (A.1988b/S.5742a).

Safeguarding Women

- Protects domestic violence survivors by requiring police officers to take custody of firearms when responding to reports of family violence (Ch. 466 of 2025).
- Supports sexual assault survivors by expanding New York State's rape kit tracking system (A.1970a/S.5225a).
- Safeguards abortion rights by requiring hospitals to provide stabilizing care to all patients, including patients with pregnancy-related emergency medical conditions (Ch. 57 of 2025).
- Modernizes New York State's outdated pregnancy loss reporting laws, ensuring greater sensitivity and protecting patient confidentiality (Ch. 57 of 2025).
