Governor Cuomo Announces School Reporting Requirements and Online Dashboard to Track COVID-19

Governor Cuomo announced that New York school districts will be required to provide the Department of Health with daily data on the number of people who have tested positive for COVID-19 in each school beginning Tuesday, Sept. 8.

The information will be publicly available on a new online dashboard developed by the Department of Health, found [here](#), where school district have now begun to post their information.

SUNY Covid-19 Dashboard

Governor Cuomo and SUNY Chancellor Jim Malatras have announced the launch of a SUNY system-wide [COVID-19 case tracker](#) dashboard. The centralized dashboard will provide real time, up-to-date information on COVID-19 cases, testing, and quarantine and isolation space availability across SUNY's 64 colleges and universities to more efficiently monitor, respond to, and contain the virus.

The COVID-19 Case Tracker dashboard will provide a case count for SUNY and for individual campuses. The data will be reported by campuses every 24 hours and added to the dashboard daily.

Guidance for Indoor Dining in New York City

Governor Cuomo announced that indoor dining in NYC will be allowed to resume beginning September 30 with 25% occupancy. Temperature checks will be required at the door for all customers and diners will be required to provide contact information for tracing if needed. Masks must be worn when not seated and tables must be 6 feet apart. Restaurants should operate with enhanced air filtration, ventilation and purification standards. Governor Cuomo Announces \$88.6 Million in Cares Act Funding Available to Assist Child Care Providers During COVID-19 Pandemic

Governor Andrew M. Cuomo today announced \$88.6 million in federal CARES Act funding is available to assist childcare providers through NY Forward grants as they adjust their programs amidst the COVID-19 pandemic. The funding is in addition to \$30 million made available in the spring and \$48.3 million recently awarded to assist childcare providers with reopening or restructuring their physical plans to meet new social distancing requirements.

Reminder: Latest Updates on Ways to Vote Absentee

To vote with an absentee ballot you must request the ballot and then return the ballot after you complete it. Ballots may be returned to any early voting location.

To request a ballot online go to the New York State Board of Elections new Absentee Ballot Application Portal to request your ballot online. Click through the web form to request the absentee ballot, which will be sent to you in the mail.

Early Voting Times and Locations

The Westchester County Board of Elections has announced the times and locations for Early Voting polling sites ahead of the November 3rd General Election.

As noted above regarding absentee ballots, you can also return your completed absentee ballot to any of these early voting locations on these dates and times.

All registered voters are eligible to cast their ballot early during the Early Voting period between **Saturday, October 24th and Sunday, November 1st**. Registered voters can go to any of the designated Early Voting polling sites to vote. If you prefer to vote on Election Day, you must vote at your assigned polling site for your Election District.

Covid-19 Travel Advisory Updates

New York, and a number of other states, maintain restrictions on individuals traveling from high Covid-19 infection states. The advisory requires individuals who have traveled to New York from areas with significant community spread to quarantine for 14 days. States are added or removed from the list based upon changing statistics.
