

Dear Friends,

Tropical Storm Ida brought historic levels of flood damage to businesses, homes and public property. Having worked on flood and disaster response issues for years, I know the challenges, pain, loss and helplessness that this kind of storm event brings.

Tragically, the storm brought loss of life with over 40 deaths in the region, including two flood victims in Rye Brook. Dedicated and beloved Iona College Professors Ken and Fran Bailie were caught in the overflow current on Lincoln Avenue. Everyone in the Iona community and in all of Westchester mourns their loss.

I toured storm damaged areas in Larchmont, Mamaroneck, New Rochelle, Port Chester, Rye and Rye Brook. The response from officials, business owners and residents was the same: for many the flood damage was worse than even the storms of 2007 and the more recent hurricanes or nor'easters. In 2007 the region had not seen a major flood event since the 1970s. Now the storms are more frequent and bring higher water levels and greater damage.

The first response needs to be to identify assistance where programs exist and provide help for those displaced. This newsletter lists some local ways you can help neighbors in need.

At the same time, we need to continue efforts in each community to fortify our infrastructure against storm impacts. On the Sound Shore the number one hazard is flooding. The NYS \$3 billion environmental bond issue, delayed last year because of Covid-19, will appear on the ballot in 2022. It includes my proposal to create a new stormwater grant program for municipalities of at least \$100 million. I will be advocating that we establish a new stormwater grant program in advance of the bond issue. We need to accelerate these essential local projects.

On Friday Senate Majority Leader Chuck Schumer, Governor Kathy Hochul and Senator Kirsten Gillibrand joined us in Mamaroneck to view storm damage, talk with first responders and commit to providing help now and to prevent future damage.



They committed to restarting the federal Army Corp of Engineers project for the Village of Mamaroneck that after years of planning and support from every level of government was blocked by the Trump Administration. Army Corp of Engineers projects take years to approve, but we were at the finish line and the project should have already been underway.

In every community there are resiliency projects that have been implemented and others that communities have studied but not acted upon. Given the increasing severity of storms, every community needs to look at the risks, assess the increasing prospects for damage, and prioritize needed projects. It is tragic and unacceptable that the same neighborhoods, not-for-profits, businesses and houses of worship suffer repeated damage in flood events.

I have also stayed in contact with ConEd and our telecommunications companies regarding service restoration, storm preparedness issues and communication with their customers and local governments. These have been longstanding issues for me as a former local official and as a member of the Assembly Committee that

oversees the NYS Public Service Commission.

Last week before the storm, the Legislature met in special session to pass legislation to modify the rules for eviction of tenants during the pandemic. Procedures were added to allow for court determination of whether a tenant experienced financial hardship because of the pandemic. Previously a property owner could not challenge such a claim because the courts were closed. The eviction moratorium, originally established by executive order, then by statute, was not intended to forgive rent. The new funds under the ERAP program are intended to pay back-rent in order to assist both tenants and landlords.

Over \$2 billion in funding is available under ERAP to pay back-rent to property owners on behalf of tenants who could not pay rent and qualified under the program. The rollout of the program has been slow, and the modified prohibition of evictions is being continued temporarily. On the day she took office less than two weeks ago, Governor Hochul made moving that money a top priority of her administration. It is a priority for the Legislature and for me as well.

Please look for ways you can help families displaced by the flood. Please support local businesses as they reopen. They need your local patronage more than ever.

My staff and I are available to help with issues related to storm recovery, Covid-19 assistance, reopening of the schools or any issue that we can be of assistance.

President Biden Approves New York's Request for Disaster Declaration

Yesterday Governor Hochul's request for expedited approval of New York's [disaster declaration](#) was approved by President Biden. This approval will speed the process for application of federal assistance for New York businesses, local governments and families.

Ida has been declared a federal disaster that qualifies for FEMA funding to support both emergency response measures taken by local and state governments as well as individual assistance for residents who suffered damages.

FEMA will be able to offer financial assistance to residents through 'individual assistance' programs.

Please make sure you are carefully documenting all damage in writing and with photographs, receipts and other documentation.

FEMA will set up Disaster Recovery Centers (DRCs) where people can file claims for assistance in communities which are particularly damaged. The County is working with FEMA to organize DRCs throughout the county as well as mobile DRCs where residents can file online or remotely.

Those eligible for assistance are impacted residents with eligible disaster related losses.

- Damage must have occurred during the incident period of the declaration and be a direct result of the incident.
- Eligible losses include non-insured damage/loss to primary residence, damage/loss to eligible personal property.


