HERE ARE JUST A FEW OF THE PROPOSALS I AM SUPPORTING:

✓ **INCOME TAX SAVINGS:** I introduced the Affordable NY Act, which would double the current STAR exemption and permanently lower the personal income tax rates for middle-income taxpayers by 2% (A.7504).

✓ **CHILD CARE SAVINGS:** I am supporting parents and children in our state by supporting proposals that would provide financial assistance to child care providers in New York state (A.2392) and would increase funding for businesses in New York state that provide child care services (A.2393).

✓ **REDUCING THE TAX BURDEN ON SENIORS:** I introduced a proposal that would reform the school funding formula and take meaningful steps to reduce the tax burden on seniors over the age of 65 (A.5149).

✓ **ESTABLISHING PERSONAL INCOME TAX CREDITS FOR FIRST RESPONDERS:** I support a proposal that would provide a personal income tax credit of up to \$2,500 for volunteer firefighters and ambulance workers in good standing (A.1064).

✓ **CREATING REAL PROPERTY TAX EXEMPTIONS FOR VETERANS:** Ensuring our courageous veterans are supported is a top priority of mine, which is why I supported proposals that would increase real property tax exemptions for disabled combat veterans (A.5683) and also would grant real property tax exemptions to disabled veterans regardless of whether they served during a period of war (A.6058).

✓ **INCENTIVIZING COLLEGE TO WORK PROGRAMS:** I support a proposal that would create a tax credit for businesses that develop a "college to work" program, paying the tuition of individuals in exchange for future employment (A.175).

✓ **PROVIDING RELIEF TO LOCAL GOVERNMENTS FACING UNFUNDED MANDATES:** I support establishing a three-year moratorium on unfunded mandates from the state that would provide immediate relief to families, businesses and school districts statewide (A.1376).

✓ **CREATING A PATH FORWARD FOR ECONOMIC GROWTH:** I want to improve New York state's overall economic future, which is why I support a proposal to establish a Division of Regulatory Review and Economic Growth. The Division would review current regulations and eliminate those that do not promote economic growth or do not protect the health and safety of the public (A.5582).
