Lend a Hand this Holiday Season

The holidays can be a joyous time to spend with friends, family and loved ones and reflect on all that we have to be thankful for. But unfortunately, there are many New Yorkers who struggle to make ends meet and may not even know where their next meal will come from. As we prepare for the upcoming holiday season, it's important to remember those in our community facing food insecurity and think about what we can do to make their holidays a bit brighter.

According to the hunger-relief organization Feeding America, nearly 1 in 6 children struggles

with food insecurity in New York State alone.[1] Many of these children and their families rely on federal and local hunger prevention programs and food banks to give them the nourishment they need, and yet the federal administration has tried to cut aid to these individuals. Earlier this year, President Trump proposed changing the way the poverty level is calculated, which would underestimate the country's low-income population and keep millions of families and individuals from qualifying for assistance programs that help them put food on the table.[2]

Nothing will change unless we step up. The Assembly Majority has taken immediate action to combat poverty and fight for the struggling families in our communities. Earlier this year, the Assembly passed a state budget that provides \$4.5 million for the Empire State Poverty Reduction Initiative to continue its work reducing inequality and lifting New Yorkers up. The budget also includes \$2.3 million to ensure eligible students don't have to pay for reduced-priced meals so that they can focus on their studies – not hunger pains.

There are many ways that you can help provide local families with access to healthy food, such as supporting local food banks and soup kitchens with donations, volunteer hours or both. You can visit health.ny.gov/prevention/nutrition/hpnap/regional_foodbank_map.htm to find the regional food bank serving our area. We are blessed to have so many strategic nonprofit partners in our region such as the Regional Food Bank, The Food Pantries of the Capital Region just to name a few. I encourage you to help out this holiday season – even the smallest contribution can make a huge difference in someone's life.

With your help, we can combat hunger in New York.
