


QUESTION 1:


QUESTION 3:


QUESTION 4:


QUESTION 2:


QUESTION 5:

Do you support a consolidated primary date in April? This would result in presidential, congressional, state, and local primaries all being held on the same day. Do you support a consolidated date in April?




QUESTION 6:


QUESTION 7:

Do you support a single payer (Medicare-for-all) healthcare system?




QUESTION 8:

The Governor has made it a priority to encourage shared services between municipalities. Which of the below services would you be most supportive in sharing?




QUESTION 9:


QUESTION 10:


QUESTION 11:

Despite additional charges of corruption there has been little progress in the way of meaningful ethics reform. What in your opinion is the most important ethics reform measure that New York should enact?




QUESTION 12:

Term Length – Currently, New York State legislators are elected to a two-year term. Do you support legislators continuing to serve two-year terms (every two years having to run for re-election)?




If you answered no to (a), would you support a constitutional amendment that would increase in the length of a term to four years?




QUESTION 13A:

Term Limits – Currently New York State legislators are not subject to term limits, which means they can run for an unlimited number of two years terms. Should be igletors be subject to term limits?




QUESTION 13B:

If you answered yes to 13A, how many total years of service should a legislator be limited to?




QUESTION 14A:


QUESTION 14B:

When considering how to allocate the State's financial resources, which categories are your highest priorities? (rank highest priority as 1 - lowest priority as 13)



What if any thoughts do you have on how we can be more effective in battling this growing problem?




QUESTION 17C:

If opioid settlement funds become available similar to tobacco settlement funds, how do you think any funds received by New York State should be directed?




QUESTION 18:

Just over 90% of patients continued to receive prescription opioids after an overdose. More than half receive the prescription from the same doctor who prescribed the drugs that led to the overdose. If you are prescribed opioids, do you think a healthcare professional should be notified if you have had a drug overdose on opioids or heroin or that such information should be placed on a registry available to healthcare providers before she/he prescribes additional opioids?



QUESTION 19:

Controlled safe injection sites have been proposed as a method of preventing deaths from overdoses. Safe injection sites allow individuals to inject heroin in a clean and safe environment and prevents overdoses by having immediate access to life-saving resources. There are also options available at the sites for entering treatment. Would you support safe injection sites that allow supervised drug use?
