■ Bills Passed (Awaiting Governor Signature)

■ Holocaust Memorial Bill (S.5784/A.7614)

This legislation creates the official New York State Holocaust Memorial. It commemorates the victims of the Holocaust while educating future generations about its history and the dangers of antisemitism, racism, and all manifestations of intolerance. I'm honored to have worked on this with my legislative colleagues in the Capital Region, in addition to the organizations that brought this across the finish line. I look forward to the Governor's support as we await signing this into law.

■ Civil Litigation Efficacy Omnibus Bill (S.8411/A.8869)

This bill is an omnibus, meaning there are multiple changes tied into this one piece of legislation. C.L.E.O aims to preserve state and local resources by streamlining legal processes, ensuring expedient justice. The bill also protects whistleblowers from intimidation, secures real-time, direct access to the database for firearms seized by law enforcement, and, most importantly, clarifies the Attorney General's authority to combat systemic discrimination and abuse of students. As a litigator, I was honored that the Attorney General trusted me with this bill. As a freshman legislator, I was extremely proud to debate it on the floor and bring it across the finish line.

■ Crime Victim Notification Bill (S.7546/A.6332A)

This bill requires the District Attorney's Office, or their designee, to mail the final disposition of a felony case to the named crime victim if they do not appear in court for the final sentencing date. This legislation was the result of many months of hard work, had strong bipartisan support, and will provide much-needed clarity and closure to crime victims across New York State.

■ Bills Introduced

I'm proud to have introduced these bills (and many others!) this session to support our community and move the 109th Assembly District forward. It's been a busy session, and the work is not over! I remain active in introducing legislation, even while we're out of session - make sure you are signed up for my email blasts and subscribed to my social media accounts so you can stay updated.

■ Potholes Bill, A.8056

Did you know that if your car suffers damage from a state highway, you are only able to sue New York State if the incident occurred between May 1 and November 15? My bill A8056 will change that. This bill allows for everyone to sue New York State when they need to, year-round, essentially incentivizing government to take care of these potholes and defects in State roads!

■ Towing Fee Bill, A.8858

This bill ensures that if your car or a larger vehicle is towed outside of New York City, you won't be hit with sky-high towing or storage fees. It sets a fair limit on what towing companies can charge, protecting people from being exploited by outrageous or unexpectedly high fees, which has become a serious problem in many parts of New York State.

■ Electronic Bail Bill, A.6782

This bill allows people to pay bail, fines, and other court fees online. Currently, making these payments can be complicated and inconvenient, which sometimes leads to extra penalties for late payments. By offering an online option, it becomes easier and faster for people to take care of what they owe, benefiting both the courts and those making the payments.

■ Gender-Affirming Care Bill, A.8191

This bill would allow New York State to establish a continuation of care program for people who rely on gender-affirming care. Once this program is created, it would consult subject matter experts to identify providers and offer them funding and resources to support their mission. Now more than ever, this legislation is essential to ensuring that everyone receiving life-saving treatment can continue to access it.

■ An Update on Quality of Life

Albany Navigates Health and Housing Program

Albany Navigates is an emerging program that began as a joint city-county pilot on Lark Street in the spring and summer of 2023.

The program has now secured \$1.8 million in funding for the next three years and addresses unsheltered homelessness, mental health, addiction, and housing needs. It will also help participants navigate services through case management and connections to essential resources. The goal is simple but vital: to connect people with the support they need to survive, because no one deserves to be without shelter.

Members of the public can refer to Albany Navigates, but participation must be voluntary. The program prioritizes trust-building before formal engagement begins. A similar initiative, New York State's **Safe Options Support (SOS) program**, works alongside Albany Navigates to coordinate care for Albany's unhoused population. A new effort, **Supporting Your Neighbors Collaboratively (SYNC)**, aims to streamline outreach and case planning while reducing duplication among service providers.

Involuntary Commitment

This year's budget updated the legal definition of involuntary commitment to include individuals at substantial risk of physical harm due to mental illness that prevents them from meeting their own essential needs. This change allows for earlier intervention, **connecting our most vulnerable neighbors to necessary resources and treatment** before their situations escalate.

From my perspective as a former public defender, this change has the potential to prevent crises for people who actively seek or desperately need help but are unable to get it in time.

I remain committed to protecting our most vulnerable communities and keeping the 109th Assembly District, and all of New York, safe.

Mental Health Resources

Modernized Discrimination Reporting Process

New York State has made it easier to report discrimination. Trained agents can guide you through the process in real time, file the report for you, and offer interpretation services in languages other than English. No attorney is required, and the service is completely free.

■ In/Out of Chamber - Best of 2025

■ Something wonderful is coming to the Frank Chapman Memorial Institute! Earlier this summer, I invited Assembly Speaker Carl Heastie to the Chapman Institute for a tour of one of West Hill's most essential nonprofits. We finished the day with a \$1.25 million state investment for both the Chapman Institute and Hood's House of Hoops. This investment will have ripple effects for the whole West Hill neighborhood, and I couldn't be more excited to deliver this for the City of Albany residents.





- Earlier this year, the federal government stripped Sgt. Henry Johnson of a well-deserved honor by renaming Fort Johnson back to Fort Polk, despite nearly a century of advocacy to secure his posthumous Medal of Honor. I joined Assemblymembers Phil Steck and John McDonald, Senators Pat Fahy and Jake Ashby, and Mayor Kathy Sheehan to announce new legislation that would rename the Patroon Island Bridge in honor of Albany's own Sgt. Henry Johnson.
- In June, I was proud to attend the announcement of full funding for Phase One of the Empire State Plaza decarbonization plan. I helped secure \$136 million in the FY 2026 state budget for this project, which will cut emissions at the Plaza by 20%, bringing cleaner air, modern energy systems, and good-paying jobs to Sheridan Hollow. I'll continue working closely with community advocates to keep this project moving forward, it's thanks to their efforts that we've reached this milestone.
