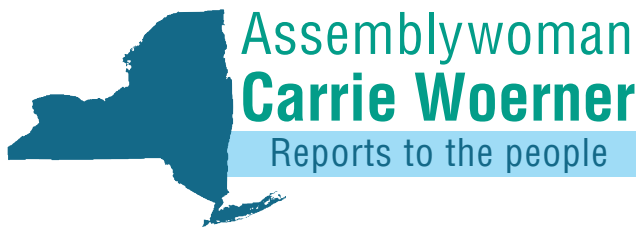

## Legislative Highlights

**In addition to helping pass the 2018-19 state budget, Assemblywoman Woerner authored multiple pieces of legislation that were signed into law.**

To help ease the burden on local taxpayers and promote environmental conservation, I authored legislation **requiring New York State to pay taxes on 600 acres of grasslands that were recently acquired in Washington County**. The state Department of Environmental Conservation will purchase the land – located in the towns of Argyle, Fort Edward, and Kingsbury – and the Friends of the IBA will be tasked with managing the property and preserving its wildlife habitats. The state already pays taxes on preserved land in other parts of the state, and it was only fair that Washington County received the same benefit (*Ch. 196 of 2018*).

Affordable health care is a right that every New Yorker should be able to enjoy. But far too often financial barriers prevent our families from getting the care they need and strain local budgets and taxpayers. That's why I passed legislation **enabling HMOs to offer employees of certain municipalities a group high-deductible health plan in conjunction with a health reimbursement or savings account** (*Ch. 264 of 2018*).

To encourage schools to purchase food directly from New York State farmers, I spearheaded a bill **eliminating bureaucratic red tape so farmers can sell more of their**

**products and students can access even more nutritious, locally sourced food**. This change allows county boards to adopt their own policies and procedures regarding these food purchases, without having to wait for state approval (*Ch. 371 of 2018*).

In order to eliminate unnecessary and costly travel expenses, I passed legislation to **make all the pre-licensing coursework for insurance agents available remotely**. Previously, courses for personal lines insurance, such as property, could only be completed in person. This requirement made it difficult for small, rural agencies to take on new employees and compete with their larger competitors. My legislation will help level the playing field for businesses in Washington and Saratoga counties (*Ch. 365 of 2018*).

I also passed a law to **include the communities surrounding Round Lake among the list of inland waterways eligible for the New York State Local Waterfront Revitalization Program**. The program helps communities attract business development, preserve vital ecosystems, and obtain public and private investment (*Ch. 133 of 2018*).

## Legislative Highlights (cont.)

To further stimulate redevelopment and unlock additional revenue sources, I authored a measure **allowing businesses in the village of Hudson Falls that are near houses of worship to obtain retail liquor licenses**. By eliminating this archaic restriction, we can ensure that Hudson Falls can continue to grow and flourish (*Ch. 240 of 2018*).

The craft beer industry is thriving all across the Empire State, and it's critical that we continue to promote this burgeoning field. In talking with the owners of Dry Town Hops in Argyle and R.S. Taylor and Sons Brewery in Saratoga, I learned that hopyard growers still face significant challenges. That's why I passed a law **extending the same real property tax abatement that vineyards and orchards already receive to hopyards** (*Ch. 192 of 2018*).

To better ensure the safety of Hudson Falls residents, I passed legislation **making one of the village's part-time police officers eligible to sit for the civil service exam to become a full-time officer** (*Ch. 122 of 2018*).
