This year has been a busy one for the Assembly. My colleagues and I worked hard to pass legislation to improve the lives of families in the 128th District and across the state.

Insurance Reform

- Allows small businesses to purchase insurance policies with a term of less than one year (A.5379)
- Allows insurers from outside New York State to include services by telephone, video call, fax, web portal and other electronic means in certain circumstances (Ch. 266 of 2021)
- Authorizes the Liverpool Central School District to establish insurance reserve funds (Ch. 215 of 2021)

Veterans' Rights

- Ensures veterans suffering from health issues due to exposure to toxic burn pits can pursue a cause of action in New York courts without being barred by the typical period of limitation (A.4474-A)
- Provides a more streamlined way for coroners and medical examiners to report deaths of veterans appearing to be suicides to the state Division of Veterans' Services (A.3237-A)

Wildlife Management

 Allows hunting, fishing or sale of certain species by members of Native tribes or nations which are otherwise prohibited by state regulations (A.6248) Extends the authority of the Department of Environmental Conservation (DEC) to manage white-tailed deer and black bears (Ch. 207 of 2021)

Driver's License Reform

- Clarifies that all drivers can pay outstanding penalties in installments to satisfy requirements for license reinstatement (A.7874-A)
- Limits the grounds for the suspension of a driver's license and clarifies several provisions included in Chapter 382 of the Laws of 2020 relating to driver's license suspension reform (Ch. 76 of 2021)

Miscellaneous Statutes

- Authorizes the payment of camp fees for children receiving safety net assistance or family assistance provided such funds cannot be obtained from other sources (Ch. 126 of 2021)
- Enables local districts to promote re-engagement of welfare recipients in welfare work activities and provides recipients with a time frame during which to request reengagement (A.3227)
- Provides a credit for NYS Fair vendors who purchased liquor licenses for the cancelled 2020 State Fair (A.7411-A)
