It has been a blessing to be able to see so many of you in person. I have been meeting many of you during my mobile office hours, which will continue through early December, or at local events I have attended. I love hearing comments, questions, and concerns directly from you so I can continue to be your voice in Albany.

I wanted to highlight some of my favorite fall activities in the district. If you love witnessing the landscapes dressed in golden colors while the leaves fly with the wind, some of these will be your perfect fall activities.

Head to Bristol Mountain (5662 NY-64, Canandaigua, NY) and experience the Fall Sky Rides. You can ride the Comet Express, chairlift to the summit of the mountain, and take in the view of Bristol Hills and the valley below.

For fall foliage and scenic trails, visit High Tor Wildlife Management Area (3996-3960 Donley Rd., Naples, NY). Featuring 6,315 acres of wilderness, this family-friendly destination offers miles of trails and roads where cyclists, hikers, runners, and walkers can enjoy all the splendors of fall.

At 2,256 feet, Gannett Hill Park (6475 Gannett Hill Park Dr., Naples, NY) is a scenic spot that ranks among the highest points in Ontario County and offers one of the best views around. Locals call it "The Jump Off," a breathtaking panorama that becomes even more spectacular as fall deepens.

Letchworth State Park - drive through and look at the fall colors.

Visit Great Brook Apple Farm (1640 NY-444, Victor, NY) to lose yourself among the orchards.

### **Legislative Updates**



I will not back down until I see changes made to NYSERDA's Draft Energy Plan. I strive to be a strong voice for my constituents, and I want to be the best representative for you that I can be. I have been all around the district, attending local events and holding mobile office hours to hear your voices. A common theme that kept arising was energy, and New Yorkers have had enough.

### **Legislative Updates**

A common theme that kept arising was energy, and New Yorkers have had enough. In rural upstate New York, where many families rely on alternatives to electric heating, the idea of losing the freedom to choose how to heat your home is deeply troubling, especially for those planning to build in the coming year.

We're also seeing a heartbreaking trend: residents aged 24–44 are leaving New York in record numbers. The leading cause? Affordability. First-time homeowners and young families are struggling just to stay afloat.

Below is a letter I sent directly to NYSERDA (New York State Energy Research & Development Authority), along with the local media. This letter outlines the concerns I have heard directly from you. Although it is a small act, I hope it represents our district's displeasure with NYSERDA's draft energy plan.

As a proud representative of New York State, I submit these comments to express serious concerns about the current direction of the Draft Energy Plan. While I fully support our collective commitment to a cleaner, more sustainable future, I believe the plan's electrification mandates and compressed timelines require a more balanced, affordable, and inclusive approach.

Affordability Must Be Front and Center: The proposed mandates for full electrification—particularly in heating and transportation—are ambitious, but they risk placing an unsustainable financial burden on New Yorkers every day. Retrofitting homes, replacing appliances, and upgrading infrastructure are costly undertakings. Without robust financial support and realistic timelines, we risk leaving behind working families, seniors, and small businesses who simply cannot afford these transitions.

**We Must Address Outmigration:** New York is already facing a troubling trend: residents and businesses are leaving. High costs, regulatory pressures, and economic uncertainty are driving this outmigration. If we fail to manage our energy transition with economic sensitivity, we will accelerate this trend and weaken our communities. We must ensure that our energy policies do not inadvertently push people out of the state.

**Diversification Is Key to Sustainability:** Electrification is one piece of the puzzle—not the whole solution. A resilient and sustainable energy future requires a diversified portfolio that includes:

- Renewables like solar and wind
- Responsibly managed natural gas
- Hydrogen and bioenergy
- Advanced nuclear energy, which offers zero-emission baseload power and technological promise for longterm reliability

Overreliance on a single energy stream, especially electricity, during peak demand or extreme weather could jeopardize grid reliability and public safety. Natural gas and nuclear must be part of the conversation if we are serious about decarbonization and energy security.

A Call for Balance and Equity: I urge the state to revise the Draft Energy Plan to:

- Pause implementation timelines to allow for economic and infrastructure adaptation
- Conduct thorough affordability analyses and provide meaningful financial support
- Embrace a diversified energy mix—including natural gas and nuclear—to ensure reliability and resilience
- Prioritize regional equity and community engagement throughout the transition

New York's energy future must be bold—but it must also be balanced, affordable, and inclusive. I stand ready to work with my colleagues, stakeholders, and constituents to ensure that our path forward reflects the needs and realities of all New Yorkers.
