Dear Mr. Speaker:

It is my privilege to submit to you the 2016 Annual Report for the Assembly Standing Committee on Mental Health and Developmental Disabilities. This year the state continued to take steps toward completing the transition of behavioral health and developmental disabilities services and supports from Medicaid fee-for-service to a managed care service delivery model. It will be essential for the Committee to continue to closely monitor this transition and engage with advocates and service providers to ensure that individuals receive quality care, and that programs are funded properly and meet the needs of those who require services.

The Committee continues to diligently watch other important changes occurring throughout the behavioral health and developmental disability systems, including the implementation of behavioral health organizations (BHOs), health homes, and the execution of New York's Olmstead Plan. The Committee will also continue to advocate alongside their colleagues in the Assembly Majority to secure additional funding for behavioral health and developmental disability programs to provide both a living wage for their staff and high quality supports and services to individuals with disabilities. Without an increase in funding, these programs will be unable to recruit and retain qualified staff, and further face the threat of severe economic hardship, putting at risk the service and support system which is responsible for the care and safety of some New York's most vulnerable citizens.

The Committee is dedicated to ensuring that the needs and rights of individuals with mental illness and developmental disabilities are kept at the forefront throughout many of these changes that will vastly impact the service delivery system.

During the 2016 Legislative Session, the Committee also reviewed numerous bills which focused on strengthening individual rights and requiring higher quality of care and safety for individuals served in the mental hygiene system.

In closing, I would like to thank you for your leadership and support of the Committee on Mental Health and Developmental Disabilities. I look forward to 2017 as we develop solutions to the challenges we face.

I. INTRODUCTION

The Assembly Committee on Mental Health and Developmental Disabilities has jurisdiction over legislation affecting programs that provide services, care, treatment, and advocacy for individuals with various disabilities. The Committee focuses on ensuring that individuals with a mental illness or a developmental disability and those with multiple disabilities are provided appropriate and necessary services to live a fulfilling life and are protected from abuse or harm in institutional and community settings.

The Committee has legislative oversight of programs administered and licensed by the State Office of Mental Health (OMH) and the State Office for People with Developmental Disabilities (OPWDD). The Committee also has statutory oversight of the Justice Center for People with Special Needs (Justice Center), the Developmental Disabilities Planning Council (DDPC), the Inter-Office Coordinating Council (IOCC), and the Most Integrated Setting Coordinating Council (MISCC).

The aforementioned agencies are expected to serve nearly one million individuals in 2017-18, including persons with mental illness, individuals with developmental disabilities, and their families. The Committee also works closely with the New York State Assembly Standing Committee on Alcoholism and Drug Abuse, the Assembly Standing Committee on Veterans Affairs, the Assembly Standing Committee on Correction, and the Task Force on People with Disabilities.

During the 2016 session, the Committee reviewed a number of bills and addressed many issues aimed at providing quality services, enhancing protections, and increasing access to services for individuals with various disabilities.

This report describes the Committee's major legislative activities during the 2016 session.

II. STATE BUDGET HIGHLIGHTS

Over the past several years, the mental hygiene service system has experienced significant cuts and sweeping changes to funding structures of programs under the auspices of the Office of Mental Health (OMH) and the Office for People with Developmental Disabilities (OPWDD). That being said, the State Fiscal Year (SFY) 2016-2017 enacted budget provides some relief and much-needed support for individuals with a mental illness and developmental disabilities and for those who care for these individuals. Within OMH and OPWDD, the following proposals and appropriations were enacted in the 2016-17 budget:

A. Increasing the Minimum Wage

The issue of providing a livable wage for all New Yorkers was a major topic of discussion throughout this year's budget negotiation. The enacted budget commits a total of \$8.4 million to support the needs of the OMH and OPWDD service providers. The Committee is in support of the budget agreement to phase in a \$15 per hour minimum wage. However, New York State must ensure that funding is made available to not-for-profit behavioral health and developmental disability service providers in a timely manner so they can fund the wages of their staff without negatively impacting the delivery of services.

B. Expanding Crisis Intervention Teams (CIT) and Diversion Programs

The budget provided \$1.5 million to support CIT training for law enforcement professionals, and to support the development of alternative mental health diversion programs. These programs train law enforcement for situations involving individuals with mental illness to help reduce the number of individuals unnecessarily hospitalized or arrested.

C. Supported Housing for Individuals with a Mental Illness

The budget provided \$38 million for supported housing and services for individuals with a mental illness who are currently living in an adult home. This initiative is designed to increase long-term housing options combined with individual support services for individuals with mental illness, which will facilitate the independence of each individual served.

D. Children's Mental Health Services

The budget committed \$7.5 million in new funding for the expansion of children's mental health services. These new services will include off-site services, crisis intervention, community psychiatric supports and treatment, psychosocial rehabilitation services, family peer and support services, and youth and peer support and training. This funding is expected to grow to \$30 million in SFY 2017-2018. These resources are essential to ensure a successful transition of children's mental health services into Medicaid managed care.

E. Person-Centered Services for Individuals with Developmental Disabilities

The budget provided \$30 million in state funding to administer new person-centered services for individuals with developmental disabilities, including certified and non-certified residential services, day supports, employment services, and respite services. As the state transitions away from institutional settings, increasing capacity for services in the community is critical to providing appropriate levels of care for this population.

F. Developmental Disability Crisis Services

The budget provided \$15 million for crisis services by expanding the NY-START model to other OPWDD regions. Currently utilized in in Regions 1 (Western NY) and 3 (Capital Region and Hudson Valley), NY-START is a community-based program that provides crisis prevention and response services to individuals with intellectual and developmental disabilities with complex behavioral health needs, as well as their families.

G. Health Care Transformation Program

The budget allocated \$195 million in capital funding for healthcare transformation statewide, and specifies that a minimum of \$30 million be provided to community-based health care providers, including diagnostic & treatment centers, mental health clinics, and alcohol and substance abuse treatment clinics.

III. SIGNIFICANT LEGISLATION

1. Access to Services for Individuals with an Autism Spectrum Disorder Diagnosis A.171-A (Abinanti) / S.2562-A (Parker) Passed Assembly

This bill would require the Commissioners of OPWDD, the State Department of Education (DOE), the Department of Health (DOH), the Office of Children and Family Services (OCFS), and OMH, to study and issue a report on the cost of early diagnosis of autism spectrum disorder and long-term treatment for individuals with autism spectrum disorder.

2. Developmental Disability Service Provider Employee Training Curriculum

A.777-A (Gunther) / S.2466-A (Ritchie) Passed Assembly

This bill would require the commissioner of OPWDD to develop an educational curriculum for all providers operated or licensed by the agency. The educational curriculum must include training in abuse, neglect and maltreatment indication and prevention; laws, regulations and procedures governing the protection of persons with disabilities from abuse; neglect and maltreatment; identification, safety and security procedures; fire safety; first aid; cardiopulmonary resuscitation; cultural competence, and: any other appropriate topic. In developing such curriculum, the commissioner shall conduct a literature review of reports, studies and other models regarding the training of direct care workers who work with individuals with disabilities.

3. Legal Services for Individuals with a Serious Mental Illness

A.1459 (Cusick) / S.1907 (Parker) Passed the Assembly

This bill would ensure adequate legal representation for individuals diagnosed with a serious mental illness by authorizing Mental Hygiene Legal Services to provide legal assistance to patients or residents who are discharged from a mental hygiene facility to a health care facility licensed pursuant to Article 28.

4. Right to Counsel for Individuals with Developmental Disabilities

A.3866 (Brennan)
Passed the Assembly

This bill would establish the right to legal representation for any person receiving services from a program licensed or operated by OMH or OPWDD and is interviewed as part of an investigation by the Justice Center for the Protection of People with Special Needs. Such representation would be provided by either Mental Hygiene Legal Services or privately retained counsel.

5. Legal Representation for Individuals with a Mental Health Diagnosis

A.5431 (O'Donnell)
Passed by the Assembly

This bill would provide access to mental health records for attorneys that are representing inmates in disciplinary hearings and other proceedings, who currently reside in a correctional special housing unit or a residential mental health housing unit.

6. Reducing Stigma against Mental Illness

A.6386-A (Gunther) / S.840-A (Robach) Chapter 246

This law authorizes the Commissioner of OMH and OMH facility directors to release information for the purpose of marking the graves of former patients of OMH facilities.

7. Improving Safety and Quality of Care for Out of State Placements

A.7226-A (Gunther) / S.7584 (Ortt) Chapter 107

This law authorizes the Justice Center to visit, inspect, and appraise the management of residential schools and facilities outside of New York State that serve New York residents.

8. Mitigating Neglect and Abuse in Developmental Disability Service Settings

A.7533 (Abinanti) / S.7188 (Avella) Passed Assembly

This bill would require programs subject to regulation by OPWDD, to post a visible notice informing employees to call 911 in the event of an emergency and directing them to make

required reports relating to abuse or neglect to the Justice Center or to law enforcement.

9. Protection and Advocacy for Individuals with a Disability

A.9117 (O'Donnell) / S.6622 (Ortt) Chapter 453

This law provides the agency charged with providing protection and advocacy services with access to clinical mental health records, free of charge.

10. Improving Transparency of Services and Supports Provided by OPWDD

A.10053-A (Gunther) / S.7644 (Ortt) Chapter 250

This law requires OPWDD to publish quarterly updates on the progress of the State's Olmstead implementation plan on its public website.

11. Assisting in the Implementation of the ABLE Act

A.10206 (Gunther) / S.7882 (Carlucci) Chapter 149

This law will facilitate the implementation of the New York State ABLE Savings Account Program by authorizing the Comptroller to contract with the existing third party administrator of the NYS College Choice Tuition Savings Program for the purpose of administering the NY ABLE Savings Account Program, and provide the Comptroller with the option to permit the programs to be administered jointly or separately by a 3rd party vendor.

12. Direct Support Professional Workforce Development

A.10409 (Gunther) / S.7677-A (Ortt) Veto Memo 215

This bill would direct the Commissioners of OPWDD and DOH to identify the causes and determine the impact of high vacancy and turnover rates for non-profit providers delivering supports and services to individuals with intellectual and developmental disabilities, and identify the resources necessary to maintain a quality workforce in the direct support professional field.

13. Removing Barriers to Developmental Disability Services for Dependents of Military Service Members

A.10461-A (Englebright) / S.6915-B (Ortt) Chapter 488

This law authorizes dependents of military service members to retain eligibility for services regardless of leaving the State, as long as they retain residency and remain eligible for services. This law also allows dependents residing out-of-state to be placed on the waiting list for services if they left the state due to the military service member's military assignment.

14. Ensuring Safe Care and Treatment Settings

A.10556 (Titone) / S.7410-A (Carlucci) Chapter 209

This law authorizes OPWDD developmental centers to access criminal history information of individuals coming into care in order to assist clinicians and staff in making care and treatment decisions.

15. Improving Coordination and Services for Individuals with Autism

A.10558 (Santabarbara) / S.8036-A (Nozzolio) Chapter 469

This law requires OPWDD to establish an Autism Spectrum Disorder (ASD) advisory board to review, identify, and monitor supports and services provided to individuals with ASD.
