SUBJECT: Incentives for Community Solar

PURPOSE: To examine whether the existing incentives and crediting mechanisms are

sufficient to ensure community solar remains a viable component of the renewable energy mix to meet the new clean energy targets within the NYS

Climate Leadership and Community Protection Act (CLCPA).

The Climate Leadership and Community Protection Act (CLCPA) requires the Public Service Commission (PSC) to establish a program requiring six gigawatts of installed distributed solar by 2025 and no less than 70 percent of electricity to be generated by renewable energy systems, including solar, by 2030. Ensuring sufficient renewable energy compensation and incentives will be an important component of meeting that goal. On April 18, 2019, the PSC revised the Value of Distributed Energy Resources (VDER), which fully replaced net metering after January 1, 2020, for determining the compensation for distributed energy resources like solar. The purpose of this hearing is to examine whether the existing crediting mechanisms and incentives associated with VDER are sufficient to meet the 70 percent goal of the CLCPA.

Persons wishing to present pertinent testimony to the Committees at the above hearing should complete and return the enclosed reply form as soon as possible. It is important that the reply form be fully completed and returned so that persons may be notified in the event of emergency postponement or cancellation.

Oral testimony will be limited to ten minutes' duration. In preparing the order of witnesses, the Committees will attempt to accommodate individual requests to speak at particular times in view of special circumstances. These requests should be made on the attached reply form or communicated to Committees' staff as early as possible. Ten copies of any prepared testimony should be submitted at the hearing registration desk. The Committees would appreciate advance receipt of prepared statements.

Attendees and participants at any legislative public hearing should be aware that these proceedings are video recorded. Their likenesses may be included in any video coverage shown on television or the internet.

In order to further publicize these hearings, please inform interested parties and organizations of the Committees' interest in hearing testimony from all sources.
