While the unemployment rate has continued to slowly decline, millions of Americans are still out of work, or are forced to work limited hours due to business closures or other issues. According to the Bureau of Labor Statistics, as of July, 10.2% of Americans were still unemployed, with tens of millions still working limited hours due to the COVID-19 pandemic. With heightened unemployment, and the increased cost of groceries caused by a greater demand on the food supply chain as cited by the Bureau of Labor Statistics, food insecurity is an ongoing issue for many American households across the country.

According to Feeding America, prior to the COVID-19 pandemic, food insecurity in the United States was at its lowest point since the Great Recession of 2008, and yet more than 37 million people, including 11 million children, were experiencing food insecurity. Those numbers have dramatically increased during the COVID-19 pandemic, with more than 54 million people, including 18 million children currently experiencing food insecurity. Experts believe these numbers will continue to rise as the pandemic continues to ravage families' economic stability. According to The Center on Budget and Policy Priorities, the economic crisis spurred by COVID-19 has resulted in an unprecedented increase in those seeking Supplemental Nutrition Assistance Program (SNAP) benefits, with an increase of approximately 17%, or an additional 6 to 7 million people receiving SNAP benefits between February and May. In comparison, during the Great Recession, it took 17 months for states to see an increase of that kind of SNAP recipients. If unemployment levels increase again, the Center on Budget and Policy Priorities believes SNAP caseloads are likely to rise as well.

New York has not escaped the effects of the pandemic. There are currently 2.2 million people across New York State struggling with food insecurity. Additionally, the emergency supplemental SNAP funding that was included in the Families First Corona Virus Response Act of 2020 expired on July 31, 2020, therefore households have reverted back to their pre-pandemic SNAP benefit amount as of August 2020, leaving many individuals without adequate resources for food. The pandemic impacted the State's food supply infrastructure and presented many challenges for New York farms, food suppliers, processors, wholesalers and retailers which contributed to food insecurity within the State. Finally, with schools, childcare centers, and older adult meal sites continuing to close their doors, access to free food programs are continuing to become more and more limited putting more strain on overburdened emergency food programs and the need to address food insecurity has become vital. The Committees and Task Force seek to hear how stakeholders are addressing the food needs in their communities and ways to better serve the people of New York who face food insecurity issues on a daily basis.

Persons invited to present pertinent testimony to the Committees and Task Force at the above hearing should complete and return the enclosed reply form by **Friday**, **September 4th**. It is important that the reply form be fully completed and returned so that persons may be notified of means by which to testify and/or in the event of emergency postponement or cancellation.

Oral testimony will be limited to 10 minutes' duration. In preparing the order of witnesses, the Committee will attempt to accommodate individual requests to speak at particular times in view of special circumstances. These requests should be made on the attached reply form or communicated to Committee staff as early as possible.

Written testimony should be submitted via email two days prior to the hearing.

Attendees and participants at any legislative public hearing should be aware that these proceedings are video recorded. Their likenesses may be included in any video coverage shown on television or the internet.

In order to further publicize these hearings, please inform interested parties and organizations of the Committee's interest in hearing testimony from all sources.

In order to meet the needs of those who may have a disability, the Assembly, in accordance with its policy of non-discrimination on the basis of disability, as well as the 1990 Americans with Disabilities Act (ADA), has made its facilities and services available to all individuals with disabilities.
