The Assembly Standing Committee on Agriculture oversees New York State's agriculture, food, animal protection, and other regulatory programs and budgets administered by the State Department of Agriculture and Markets, providing assistance for research, marketing, promotion and consumer protection. The Assembly Standing Committee on Economic Development, Job Creation, Commerce and Industry and the Standing Committee on Small Business are responsible for oversight of the State's various economic development entities and programs which interact with the agricultural industry and those other industries and small businesses that are dependent on it. The agriculture industry in New York, including food processing, forestry and fishing, is one of the largest with almost \$50 billion in economic output and nearly 200,000 jobs. The purpose of this hearing is to examine the overall impact and implementation of the 2020-2021 State budget, including the efficacy of current investments in agriculture and related businesses down the supply chain in a year when the Covid-19 pandemic has severely impacted them. The Committees and Task Force are interested in examining the best approach to help the farming and related business community in light of a changing, competitive national and international marketplace.

Persons invited to present pertinent testimony to the Committees and Task Force at the above hearing should complete and return the enclosed reply form as soon as possible. It is important that the reply form be fully completed and returned so that persons may be notified of means by which to testify and/or in the event of emergency postponement or cancellation.

Oral testimony will be limited to 5 minutes' duration. In preparing the order of witnesses, the Committees will attempt to accommodate individual requests to speak at particular times in view of special circumstances. These requests should be made on the attached reply form or communicated to Committee staff as early as possible.

Attendees and participants at any legislative public hearing should be aware that these proceedings are video recorded. Their likenesses may be included in any video coverage shown on television or the internet.

In order to further publicize these hearings, please inform interested parties and organizations of the Committee's interest in hearing testimony from all sources.
