On the state level...

All not-for-profit applicants must now pre-qualify on the NYS Grants Reform Website at grantsreform.ny.gov/grantees to apply for certain New York State grant solicitations. Potential not-for-profit applicants are strongly encouraged to begin the process.

NYS Department of Health (DOH), Personal Responsibility Education Program (PREP)

The New York State Department of Health (NYSDOH), Bureau of Perinatal Reproductive and Sexual Health (BPRASH), announces the availability of up to \$2.1 million annually to support the provision of the Personal Responsibility Education Program (PREP) initiative throughout New York State (NYS) for the anticipated funding period of October 1, 2023, through September 30, 2028. This Request for Applications (RFA) represents the continued commitment of the NYSDOH to support comprehensive programming that fosters the prevention of adolescent pregnancy, sexually transmitted infections (STIs), and Human Immunodeficiency Virus (HIV).

The PREP initiative will support the implementation of programs that replicate effective evidence-based program (EBP) models that have been proven based on scientific research to change behavior, such as delaying sexual activity, increasing condom or contraceptive use for sexually active youth, or reducing pregnancy among youth; and activities to ensure access for youth to comprehensive reproductive health care and family planning services.

The New York State Division of Criminal Justice Services (DCJS) seeks proposals to fund safety and security projects at nonprofit organizations at risk of hate crimes or attacks because of their ideology, beliefs, or mission. Approximately \$50 million is expected to be available to fund approximately 1000 projects throughout New York State

US Department of Health and Human Services, Music and Health: Understanding and Developing Music Medicine

Music has a unique and remarkable ability to ameliorate the symptoms of a broad range of disorders that occur throughout the lifespan, deliver palliative care during serious advanced illness, improve recovery from a variety of neurological disorders, and improve health throughout all our lives. Music can clearly act as an effective medicine, but its means of action are poorly understood. This funding is intended to: increase our understanding of how music affects the brain when it is used therapeutically and/ or use that knowledge to better develop evidence-based music interventions to enhance health or treat specific diseases and disorders.

Eligibility: Public housing authorities/Indian housing authorities, independent school districts, Native American tribal governments (federally recognized), for profit organizations other than small businesses, small businesses, state governments, city or township governments Native American Tribal Organizations (other than federally recognized tribal governments), private institutions of higher education, nonprofits having a 501(c)(3) status with the IRS (other than institutions of higher education), nonprofits that do not have a 501(c)(3) status with the IRS (other than institutions of higher education), public and state controlled institutions of higher education, county governments, special district governments, Alaska Native and Native Hawaiian Serving Institutions, Asian American Native American Pacific Islander Serving

Institutions (AANAPISISS), eligible agencies of the Federal Government, faith-based or community-based organizations, Hispanic-serving institutions; Historically Black Colleges and Universities (HBCUs), Indian/Native American Tribal Governments (other than federally recognized), non-domestic (non-U.S.) entities (foreign organizations), regional organizations, Tribally Controlled Colleges and Universities (TCCUs), U.S. Territory or Possession. Non-domestic (non-U.S.) components of U.S. Organizations are eligible to apply. Foreign components, as defined in the NIH Grants Policy Statement, are allowed.
