## On the State Level...

All not-for-profit applicants must now pre-qualify on the NYS Grants Reform Website at <u>grantsreform.ny.gov/grantees</u> to apply for certain New York State grant solicitations. Potential not-for-profit applicants are strongly encouraged to begin the process of registering and pre-qualifying immediately, as this is a lengthy process.

### NYS Office of Mental Health (OMH), Treatment Apartment Program (TAP)

OMH will fund community-based services to reduce the demand for psychiatric hospitalization and long stays in inpatient settings. Up to 450 TAP housing units will be developed statewide.

- Deadline: August 9, 2023, 2 PM ET
- Awards: Awards of apartment treatment housing units will be made in each of the OMH five (5) regions. Western New York, Central New York, Hudson River and Long Island regions will be awarded seventy-five (75) units per region. New York City will be awarded 150 units.

This program supports Intensive and Sustained Engagement Teams (INSET) that are believed to be effective in reaching, engaging and helping people who are experiencing such gaps.

These 2-year grants will help start, plan and advance strong, self-sustainable UCF programs which enhance the quality of life for all New Yorkers. Grant projects must implement tree inventory, community forest management plans, tree planting or tree maintenance projects for urban and community forests in New York State. "Urban and community forest" for the purpose of this grant encompasses developed areas with street trees and maintained parks.

#### U.S. Dept. of Health and Human Services, Family Violence Prevention and Services, Culturally Specific Domestic Violence and Sexual Assault Discretionary Grants

These grants will build upon the progress of culturally specific and community-based sexual assault and domestic violence programs in reducing the pervasive and harmful impact of violence and trauma by implementing culturally relevant, trauma-informed and evidence-informed interventions for individuals and families who are from diverse, underserved and historically marginalized communities.

#### U.S. Dept. of Energy, Industrial Assessment Center (IAC) Program – IACs at Trade Schools, Community Colleges and Union Training Programs, and Building Training and Assessment Centers (BTAC) Program

This funding will create Industrial Assessment Centers (IACs) at community colleges, trade schools and union training programs, as well as create Building Training and Assessment Centers (BTACs) at institutions of higher education, including tribal colleges and universities. The new IACs will focus on high-quality skilled trades job pathways in fields such as industrial electrician, energy management, renewable energy and advanced manufacturing, while providing handson support to small and medium manufacturers.

#### U.S. National Science Foundation (NSF), America's Seed Fund

America's Seed Fund helps startups navigate the earliest stages of technology translation, investing roughly \$200 million annually in approximately 400 startups. From advanced manufacturing to artificial intelligence to biological technologies to environmental technologies, funding is available for nearly all areas of technology.

- Eligible Applicants Must:
  - Be a small business (fewer than 500 employees) located in the United States
  - Have at least 50% of the company's equity be owned by U.S. citizens or permanent residents
  - Ensure that all funded work, including work done by consultants and contractors, takes place in the United States
  - Ensure the project's principal investigator (tech lead) be legally employed at least 20 hours a week by the company seeking funding
  - Pledge that the principal investigator commit to at least one month (173 hours) of work on a funded project per six months of project duration
