On the State Level...

All not-for-profit applicants must now pre-qualify on the NYS Grants Reform Website at grantsreform.ny.gov/grantees to apply for certain New York State grant solicitations. Potential not-for-profit applicants are strongly encouraged to begin the process of registering and pre-qualifying immediately, as this is a lengthy process.

NYS Education Department, Stronger Connections Grant Program (SCG)

SCG subgrants will support high-need local educational agencies (LEAs) to help establish safer and healthier learning environments, and to prevent and respond to acts of bullying, violence and hate that impact school communities.

A "high-need LEA" in New York State for the purposes of the SCG program will be identified based on two criteria:

- 1. A minimum of 40% of students in the LEA is eligible for free meals based on direct certification through: Temporary Assistance for Needy Families (TANF), Supplemental Nutrition Assistance Program (SNAP) and Medicaid by means of the Community Eligibility Program (CEP), or through district submission of such data for students eligible for Free and Reduced Lunch; and
- 2. A minimum of 10% of the student population is chronically absent.

NYS Office of Mental Health (OMH), Mental Health Outpatient Treatment and Rehabilitative Service Program (MHOTRS), School-Based Mental Health Services for Children/Youth

National Science Foundation (NSF) and National Endowment for the Humanities (NEH), Documenting Endangered Languages Grants

This funding will develop and advance knowledge concerning dynamic language infrastructure in the context of endangered human languages — languages that are both understudied and at risk of falling out of use.

Institute for Museum and Library Services (IMLS), National Leadership Grants for Libraries

These grants support projects that address critical needs of the library and archives fields to advance practice in these professions and to strengthen library and archival services for the American public. The goals for this program are to generate projects that:

 Build the workforce and institutional capacity for managing the national information infrastructure and serving the information and education needs of the public

- Build the capacity of libraries and archives to lead and contribute to efforts that improve community wellbeing and strengthen civic engagement
- Improve the ability of libraries and archives to provide broad access to and use of information and collections with emphasis on collaboration to avoid duplication and maximize reach

Solar for All grantees will provide subsidies and other financial assistance to residential rooftop and residential-serving community solar projects benefiting low-income and disadvantaged communities; in addition to project-deployment technical assistance, such as workforce development, community outreach and other project-deployment support (e.g., interconnection technical assistance, siting and permitting support) to help overcome barriers to solar deployment.

US Dept. of Housing and Urban Development (HUD), Continuum of Care (COC) Youth Homeless Demonstration Program Grants (YHDP)

These grants support the development and implementation of a coordinated community approach to preventing and ending youth homelessness. The population to be served by the program is youth ages 24 and younger experiencing homelessness, including unaccompanied and pregnant or parenting youth. Strategic goals and several objectives undergird the plan, including:

1. Support Underserved Communities

Fortify support for underserved communities and support equitable community development for all people.

2. Ensure Access to and Increase the Production of Affordable Housing

Ensure housing demand is matched by adequate production of new homes and equitable access to housing opportunities for all people.

3. Promote Homeownership

Promote homeownership opportunities, equitable access to credit for purchase and improvements and wealth-building in underserved communities.

4. Advance Sustainable Communities

Advance sustainable communities by strengthening climate resilience and energy efficiency, promoting environmental justice and recognizing housing's role as essential to health.

US Dept. of Transportation (DOT), Reconnecting Communities and Neighborhoods Pilot (RCN)

The RCN Program supports reconnection of communities divided by transportation infrastructure — with a priority on helping disadvantaged communities improve access to daily needs (jobs, schools, healthcare, grocery stores and recreation). Funds will support planning and capital construction activities that aim to restore community connectivity through the removal, retrofit, mitigation or replacement of highways, roadways or other infrastructure facilities that create barriers to mobility, access or economic development.

Scholar Awards...

Thurgood Marshall College Fund and Sallie Mae Fund, Completing the Dream Gap Scholarships

These scholarships offer financial assistance to outstanding students attending an accredited post-secondary institution. Two hundred sixty (260) students completing a two-year, four-year or trade/vocational certificate/certification program will be selected to receive a gap scholarship of \$2,500. Students must be in good academic standing, but at risk of not returning to or graduating/completing due to an outstanding financial need, and/or emergency situation that leads to a financial aid crisis.

Eligible Applicants Must:

- Be enrolled full-time or part-time at an accredited postsecondary institution or continuous education program
 - Two-year schools
 - Four-year schools
 - Vocational/Technical certificate/certification program
- Complete their degree or program by the end of the Spring 2024 semester (can be either Fall 2023 or Spring 2024)
- Have a current cumulative grade point average of 2.75 or higher
- Be a U.S. Citizen or legal permanent resident with a valid permanent resident card or passport stamped I-551
- Be a diverse candidate
 - Diverse shall include, but not be limited to: (gender, disability, race, ethnicity, belonging to an underserved community)
- Demonstrate leadership abilities
- Demonstrate good moral character in all aspects of life, including personal, professional, educational, in the community and in online presence
- Deadline: Rolling until June 28, 2024, or until funds are exhausted

The Gates Scholarships (TGS)

These last-dollar scholarships will be awarded to outstanding minority high school seniors from low-income households. Scholars will receive funding for the full cost of attendance (Cost of attendance includes tuition, fees, room, board, books and transportation, and may include other personal costs.) that is not already covered by other financial aid and the expected family contribution, as determined by the free application for federal student aid (FAFSA), or the methodology used by a scholar's college or university.

Eligible Applicants Must Be:

- A high school senior
- From at least one of the following ethnicities: African American, American Indian/Alaska Native (proof of tribal enrollment will be required), Asian & Pacific Islander American and/or Hispanic American
- Pell-eligible
- A US citizen, national, or permanent resident
- In good academic standing with a minimum cumulative weighted GPA of 3.3 on a 4.0 scale (or equivalent)
- **Deadline:** September 15, 2023
- Award Amount: Full cost of attendance not already covered by other financial aid and the expected family contribution.
