All not-for-profit applicants must now pre-qualify on the NYS Grants Reform Website at <a href="mailto:grantsreform.ny.gov/grantees">grantsreform.ny.gov/grantees</a>. Potential not-for-profit applicants are strongly encouraged to begin the process of registering and pre-qualifying immediately, as this is a lengthy process.

# NYS Office of Mental Health (OMH), Enhanced Housing for Young Adults with Serious Mental Illness Funding

This funding will be used for the development and operation of seven Enhanced Young Adult Housing programs located throughout New York State for young adults with a serious mental illness (SMI). Each opportunity consists of apartment treatment units (five or ten) and twenty scattered-site supportive housing units. The target population for all seven programs is young adults between the ages of 18 and 25 with serious mental illness who are coming from an institutional setting or community residence, leaving foster care or are homeless. Some individuals may have a co-occurring substance use disorder (SUD) and be at various stages of recovery.



The Enhanced Young Adult Housing program is intended to improve access to behavioral health and community resources; pursue vocational/educational goals; and develop real-world skills.

#### **VIA Art Fund Artistic Production Grants**

Artistic production grants are awarded to individual artists, nonprofit organizations, and institutions to support new artistic commissions outside museum or gallery walls, within the public realm, or in non-traditional exhibition environments. Grants are awarded to projects that exemplify VIA Art's three core values of artistic production, thought leadership and public engagement. VIA does not fund in-house museum or gallery exhibitions. Support is geared toward high-impact artistic commissions presented in non-traditional exhibition venues and those mounted in the public realm.

#### Borealis Philanthropy Fund for Trans Generations (FTG), Rapid Response Grants

These grants help transgender, gender non-conforming and nonbinary people live with freedom, safety and self-determination. The FTG prioritizes funding for organizations addressing health and healing, education, anti-violence, employment, housing, criminalization, leadership development, grassroots organizing, movement building, mutual aid and direct services and arts and culture. The FTG rapid response fund will provide support for situations that require immediate response and for proactive activities that pursue strategic opportunities.

Organizations and fiscally sponsored projects based in trans communities that are facing high levels of harm and who have limited access to foundation support will be prioritized. Request examples may include the following: communications, advocacy and organizing training to defeat anti-trans legislation; direct actions that confront transphobic legislation, attempts to dismantle trans protection, or other activities aimed at harming trans communities; travel support for a timely trans convening or training opportunity; and a new project or network that is doing proactive movement-building work and needs support to lay the groundwork for this.

- **Eligible Applicants:** To be eligible, organizations or projects must be trans-led, and organizations must be tax-exempt as defined by section 501(c)(3) of the Internal Revenue Code or fiscally sponsored. Projects must be based in the United States and U.S. territories.

#### Veterans of Foreign Wars (VFW), Unmet Needs Grants

Unmet Needs is here to help America's active-duty service members and their families who have run into unexpected financial difficulties because of deployment or other military-related activity or injury.

- Eligible Applicants: Service members, currently on active duty (to include activated Guard/Reserve members) whose financial hardship is a direct result of a current deployment, military pay error at no fault of the service member, or currently pending a medical discharge due to service-connected injuries/illnesses received while on active duty. #### Alyssa V. Phillips Foundation, Grants to Assist Persons with Cerebral Palsy (CP)

Grants may be provided to those impacted by CP so that they can receive ongoing and necessary therapy treatments or medical equipment to increase independence where such benefits are not covered by medical insurance.

#### Eligible Applicants Must:

- have a diagnosed disability of cerebral palsy
- be a US citizen
- have a letter of recommendation from a healthcare professional (therapist, doctor, case manager, etc.)
- have pursued other funding options before applying with the Alyssa V. Phillips Foundation (i.e., insurance)
- be able to provide a denial letter or explanation of non-coverage if an applicant has medical insurance or government funding
- make sure that for any request involving vehicle modifications, the vehicle must not be greater than 7 years old and must have fewer than 100,000 miles.
- expect that for any item that cost over \$1,000 a portion of the total cost would be self-funded by the applicant (or another resource). Applicants are required to detail such matters for requests greater than \$1,000.
- ensure that for requests in excess of \$3,000, a portion
  of the cost must be funded through sources other than
  the Alyssa V. Phillips Foundation Applicants should
  apply to at least one other charity to enable the
  Alyssa V. Phillips Foundation to partner funds to help
  meet applicants' needs. Applicants are required to
  detail such matters for requests greater than \$3,000.

#### Additional Information:

- Currently, the Alyssa V. Phillips Foundation is limiting direct and indirect financial assistance to any one beneficiary (or the family of a beneficiary) to \$5,000 per year, with a lifetime maximum of \$10,000
