NYS Dept. of Labor (NYSDOL), Direct Entry Pre-Apprenticeship (DEPA) **Program Funding**

This funding will help to support approximately 300 participants and will support entry into NYS Registered Apprenticeship (RA) programs for underrepresented populations including women, minorities, individuals with disabilities and veterans. These grants will help communities undertake certain activities that lead to the creation of a comprehensive neighborhood revitalization strategy, or Transformation Plan. The Transformation Plan will become the guiding document to carryout subsequent implementation of the plan to achieve the program's three core goals: housing, people and neighborhood - redevelop the target housing while simultaneously directing the transformation of the surrounding neighborhood and positive outcomes for families.

These grants are designed to produce high-quality employment outcomes for workers in the Appalachian, Delta and Northern Border regions, enabling them to remain and thrive in their communities. US Dept. of Justice, Veterans Treatment Court (VTC) Discretionary Grant Program

This funding will provide financial and technical assistance to states, state courts, local courts, units of local government and federally recognized Indian tribal governments to plan, implement and enhance the operations of VTCs including service coordination, participant service and supervision coordination, fidelity to the VTC model and recovery support services. VTCs effectively integrate evidence-based substance use disorder (SUD) treatment, mental health disorder (MHD) treatment, treatment for co-occurring disorders, mandatory drug testing, incentives and sanctions and transitional services in judicially supervised criminal court settings that have jurisdiction over veterans with treatment needs in order to reduce recidivism, increase access to treatment and recovery support and prevent overdose.

Ben and Jerry's National Grassroots Organizing Program (NGO) Grants

These grants support local leadership and grassroots organizing activities. This funding will help support groups that are carrying out activities that build support and collective action to address impacts of inequity and injustice in their communities. The awarding of grants is guided by common principles of community organizing. These are:

- the organization is led by the people directly impacted by the issues the organization works on, and those people have clear decision-making power
- a plan with clear goals to gain rights, win collective political power and create positive community change
- an assessment of the problem being addressed and best tactics to employ
- outreach, networking and ally gaining activities that build support and momentum
- educational activities and events that inform and motivate and build support

Eligible Applicants Must:

- have an annual operating budget under \$350,000
- use grassroots, collective action organizing campaigns as the primary strategy for creating social change
- be a non-profit with 501(c)3 status, or have a fiscal agent with this status
- be U.S.-based and U.S.-focused
