Any reduction in their capacity would be a disservice to the people they serve, especially those who are most vulnerable and in need of specialized care.

I urge you to consider the long-term consequences and the profound impact that minimizing SUNY Downstate Hospital and University would have on our community. I respectfully request that you prioritize the preservation and enhancement of these vital institutions, ensuring that they can continue to fulfill their essential roles in healthcare, education, and research, thereby contributing to the overall health and success of our community.
