**SUBJECT:** School infrastructure and facilities.

**PURPOSE:** To examine the current state of New York's school infrastructure and facilities and study new ways to support, improve, and modernize New York State's schools and boards of cooperative educational services (BOCES).

Schools are supposed to provide a healthy, safe, and supportive environment for students to learn and grow. Throughout the country, however, our schools are deteriorating. According to the U.S. Department of Education National Center for Education Statistics, the average age of a main public school building in 2012-13 was 44 years old. Research has shown that failing school buildings contribute to lower academic achievement, overcrowding, low student morale, and greater health and safety issues. Currently, New York State invests \$3 billion annually to the nearly 700 school districts throughout the state for school construction projects. It is imperative that our state continue to invest in our school infrastructure and facilities to ensure that they are of the highest standard, so that students can receive the sound, basic education that they deserve.

The Assembly Standing Committee on Education seeks testimony examining the state of New York's aging infrastructure and facilities, as well as new ways to support, improve, and modernize our state's schools and BOCES. Additionally, this hearing seeks to examine the success of the Smart Schools Bond Act, which was passed in the 2014-15 enacted state budget to finance educational technology and infrastructure for students throughout the state.

Persons wishing to present pertinent testimony to the Committee at the above hearing should complete and return the enclosed reply form as soon as possible. It is important that the reply form be fully completed and returned so that persons may be notified in the event of emergency postponement or cancellation.

Oral testimony will be limited to 10 minutes duration. In preparing the order of witnesses, the Committee will attempt to accommodate individual requests to speak at particular times in view of special circumstances. These requests should be made on the attached reply form or communicated to Committee staff as early as possible.

Ten copies of any prepared testimony should be submitted at the hearing registration desk. The Committee would appreciate advance receipt of prepared statements.

In order to further publicize these hearings, please inform interested parties and organizations of the Committee's interest in hearing testimony from all sources.
