## ORAL TESTIMONY WILL BE BY INVITATION ONLY

Article 15-A of the Executive Law, which establishes New York State's Minority and Women-Owned Business Enterprise (MWBE) program to promote employment and business opportunities for minorities and women on state contracts, is set to expire on July 1, 2025. This statute provides the framework for the MWBE certification and procurement program and establishes targeted goals for the sourcing of services and commodities by certified MWBE businesses. Empire State Development's Division of Minority and Women's Business Development is responsible for establishing a statewide certification program, encouraging and assisting state agencies to increase MWBE participation, and commissioning a statewide disparity study per statute to evaluate the participation of MWBEs on state contracts and determine whether MWBEs have had equal access to contracting opportunities with the State. In addition, the State administers several programs through its various agencies to provide MWBEs with technical, legal, and financial assistance.

The Committees, Subcommittee, and Task Force are interested in receiving feedback from various stakeholders regarding the results of the 2024 MWBE Disparity Study as well as recommendations concerning the program overall. Testimony should include evaluations of the current structure, implementation, and utilization of the program, including the certification and re-certification processes for MWBEs, and explore whether improvements could be made to further enhance opportunities for underrepresented businesses in New York State.

Oral testimony will be limited to 10 minutes' duration. In preparing the order of witnesses, the Committees, Subcommittee, and Task Force will attempt to accommodate individual requests to speak at particular times in view of special circumstances. These requests should be made on the attached reply form or communicated as early as possible.

Ten copies of any prepared testimony should be submitted at the hearing registration desk. The Committees, Subcommittee, and Task Force would appreciate advance receipt of prepared statements.

Attendees and participants at any legislative public hearing should be aware that these proceedings are video recorded. Their likenesses may be included in any video coverage shown on television or the internet.

In order to meet the needs of those who may have a disability, the Assembly, in accordance with its policy of non-discrimination on the basis of disability, as well as the 1990 Americans with Disabilities Act (ADA), has made its facilities and services available to all individuals with disabilities.
